



National CDEM Plan review

- Commenced in 2010, paused by Canterbury earthquakes
- 2005 Plan included generic LU coordination requirements, new draft outlines more specific coordination expectations of individual LUs
- LU feedback on draft LU section in Aug-Sep 2013
- Plan to be finalised in December for commencement of Government approval process in 2014 (incl. public consultation)

Lifelines and CDEM Planning Best Practice Guide [BPG1/03]


- Audience: lifeline utilities, lifelines groups, emergency managers
- Purpose: consistency in LU's CDEM planning engagement

Lifeline Utilities & Emergency Management Director's Guideline for Lifeline Utilities [DGL 3/02]

- Audience: lifeline utilities
- Purpose: guidance on how to meet CDEM Act 2002 obligations

Lifeline utilities coordinator (LUC) training materials

- Audience: LUCs
- Purpose: introduce coordination processes and summarise actors



Why review the DGL?

- Guidance publications 10 years old
- The context is dated but most content is still relevant
- Response and exercise experience has informed process
- Lifeline utilities cluster has developed
 - e.g. LUC role
 - e.g. National Fuel Plan (and other supporting plans)
 - e.g. SCE's now common

Guideline review process

- Existing (old) DGL and BPG reviewed
- Decision: combine old DGL, old BPG, and LUC training materials
- Decision: present as Parts A & B: single purpose but two key audiences:
 - LUs and CDEM sector (organisations and senior managers)
 - LUCs (individuals who hold the LUC role)
- Includes new material: e.g. SCE functions, LUC role detail
- Greater emphasis on BCM and business risk management
- Draft issued for feedback due at MCDEM by 11 Nov 2013
- New guideline published by 24 Dec 2013

Monitoring and evaluation







- MCDEM capability assessment tool (CAT) developed 2009
- Based on National CDEM Strategy essentially covers the '4Rs'

To enhance New Zealand's capability to manage civil defence emergencies

- ResOrg insight incl. "leadership and culture" indicator set
- BoP + Auckland + Waikato lifelines groups: individual utility capability
- CHC EQ CAP: "Evaluation of the resilience of infrastructure providers..."

DGL: planning within utility organisations

DGL – business continuity management

"Business continuity planning undertaken by organisations with obligations under the CDEM Act needs to include CDEM-critical activity"



M&E – critical functions and crisis management

- Critical activity principles defined
- "Contractual complexities" robust out-sourced services
- Organisation wide understanding of plan

DGL: utilities and CDEM partnership

DGL - relationship management

"Underpinning all of these [reduction and readiness] activities is the need to have effective working relationships between lifeline utilities and CDEM Groups"



M&E – collaborative planning

- Utilities analysis and planning collectively and with CDEM (EM)
- Lifelines Group, SCE participation (EM)
- Other than dependencies analysis, BCM M&E (v1) is internal



Business continuity, emergency management or disaster preparedness plan (269)	22%	18%	16%	44%
Practiced response to disaster (267)	15%	19%	12%	54%




Resilience as effectiveness

DGL Part B – lifeline utilities coordinator (LUC)


Developed for June 2013 LUC training
