

1.0 Background:

Te Kotahi o Te Tauihu were recipients of the CDEM Resilience Fund in the 2021/2022, and 2022/2023 Financial Years. This came in two separate agreements:

- 1. \$122,550 for OPEX component of the 2021/2022 Financial Year.
- 2. \$123,000 for capital purchases (Ihu Ohotata) subject to Te Kotahi o Te Tauihu finding the remaining \$123,000 required from other srouces.

A brief summary of achievement against the investment follows.

2.0 Financial Year 2021/2022:

The following outcomes were achieved in the 2021/2022 financial year:

- A. Project Manager engaged through a Contract of Service with Ihaka Mikhail Ltd.
- B. Iwi and Māori engagement and consultation relating to the development of Te Tauihu Emergency Strategy completed.
- C. One CIMS training purchased and provided to Marae/Māori community. CMS training also provided by Emergency Management Groups.
- D. Ipu Ohotata launched at Waikawa Marae and Hauhunga Marae.
- E. Four Marae had written Marae Emergency Management Plans.
- F. Trained Māori CIMS kaimahi involved with Marlborough flooding declaration response.
- G. Funding secured from Rata Foundation for 50% contribution towards 8 ipu ohotata (emergency containers).
- H. Participation NEMA Ohu Mahi roopu.
- I. Development of Rautaki ā Whānau Plan, which combined medical, disaster and fire emergencies all rolled into one.

3.0 Financial Year 2022/2023:

The following outcomes were achieved in the 2022/2023 financial year.

- A. Te Tauihu o Te Waka a Māui Emergency Management Strategy approved by iwi and three year work plan developed.
- B. Te Tauihu presentation at Te Kotahitanga o nga Tai, Porirua September 2022.
- C. Trained Māori CIMS kaimahi involved with both declarations at EOC and community outreach levels.
- D. Marae Emergency Management Team network developed and meet quarterly.
- E. Another three Marae Emergency Management Plans completed.
- F. Participation on the Marlborough, and Nelson/Tasman Mayoral Relief Funds.
- G. Organise and facilitation of Marlborough Sounds Future Access Study for lwi at Waikawa Marae.
- H. CIMS training provided and a database of over 27 CIMS3/4 lwi/Marae/Māori are available to support an emergency declaration response and recovery.
- I. Funding sought and provided by Te Pūtahitanga o Te Waipounamu for an lwi Emergency Management Navigator to support those whānau impacted by recent declarations.
- J. Funding provided by Rata Foundation and Lottery Discretionary Fund to assist with iwi participation in the Recovery process.
- K. Participation in Recovery processes from August storms including, Social Recovery, Psychosocial, Community Consultations, and Marlborough Sounds Future Access Study mahi.
- L. Support to lwi/Marae/Māori affected by Cyclone Gabriel by MSTeams, where information, policies and processes were shared. Similar request from Taranaki and support provided.
- M. Ipu Ohotata established at Omaka Marae, Tua Matene Marae, Te Hora Marae, Te Awhina Marae, Onetahua Marae, and Whakatu Reserve (next to Whakatu Marae).
- N. Iwi Māori EOC Operations Response Manual completed.
- O. Iwi Emergency Management Introductory Course developed.

- P. Rāhui presentation to Te Whatu Ora Public Health, in times of emergency.
- Q. Work commencing on Māori Incident Management System.
- R. Project Aroha for Cyclone Gabriel, with iwi providing pallets of kai and water to Tai Rawhiti.
- S. Participation NEMA Ohu Mahi roopu.
- T. Funding secured from Te Toi Whakaruruhau o Aotearoa for a local researcher to complete a case study on Te Tauihu experiences in emergency management.
- U. Two iwi kaimahi attending Controllers training on the 15th and 16th June 2023.
- V. One kaimahi completes the Post Graduate Certificate in Emergency Management.
- W. Several Marae provide accommodation, meals and support as part of declarations.

4.0 Summary

First of all acknowledgement to our eight manawhenua iwi who came together and supported a collaborative cohesive approach to emergency management. Nga mihi nga iwi o Te Tauihu o Te Waka a Māui.

Secondly to our partners Marlborough Emergency Management Group and Nelson Tasman Emergency Management Group, we have worked side by side and the results are due to the joint effort of us all. To our Marae and Māori kaimahi and whānau who have all contributed, ngā mihi kia koutou. And our key funders NEMA, Department of Internal Affairs, Te Pūtahitanga o Te Waipounamu, Rata Foundation, thank you.

The past two years have been one of capability and capacity building, and we thank everyone for getting us to this point. It has been a rewarding journey, but one which has taken concerted effort and fairly time consuming trying to piecemeal resources together to enable this level of development across the rohe.




Figure 3 Marlborough EOC Iwi Liasion
