Executive summary

Local marae are the logical options for emergency accommodation and food for people who are displaced¹. Marae have a strong history and capacity to provide manaaki or hospitality and are therefore suitable options for emergency response coordinators. The Taranaki welfare plan identifies marae as an important option for emergency accommodation, but currently there is no assurance that the marae are prepared for Civil Defence emergencies. The lack of clarity around the process to use marae as either Emergency Centres or Emergency Accommodation Centres can potentially undermine this relationship with the marae for the future.

The project being proposed has two parts, the first part is to address and resolve the issues around using marae for Emergency Centres and Emergency Accommodation Centres, especially around protocol for payment process. The second part of the project is to support four to six Marae to become Emergency Centres and/or Emergency Accommodation Centres. This includes ensuring they are prepared for an emergency by having emergency supplies, equipment, and suitable communication methods, and material around preparedness and resiliency for whanau and marae.

Problem/opportunity

The relationship between marae in Taranaki and Taranaki CDEM is limited to when marae are asked to serve as accommodation centres and welfare centres. In the past providing manaaki or hospitality has proved a burden on the local marae because of the trouble recouping payment for the accommodation and catering services provided. This resulted in marae financially burdened as a result of providing emergency support. It has lead to straining the relationships with CDEM in Taranaki. In addition, in spite of the dependence on marae to provide emergency accommodation in the event of a disaster, no investment has been made to support Marae Emergency Preparedness and Response Plans.

Marae support their local iwi and have in the past been positive place for social change in the Maori community. Supporting the marae to function well as Emergency Accommodation Centre, and having these organisations prepared to respond to an emergency is a priority for Taranaki CDEM.

The anticipated Long term outcomes of this scoping work are:

- Better relationship and awareness of role with individual marae and Civil Defence Emergency Management
- Develop clear administrative process for the use of maraes for emergency accommodation and food from day 1-3 and from day 3 plus.
- Clarify the reimbursement process for marae and address any barriers around this process
- The development of Marae Emergency Preparedness and Response Plans across Taranaki marae
